

SUMMARY OF AGREEMENTS

My organization will comply with the Heads Up Football® Membership Terms and Conditions, which specifically include-but are not limited to-the following requirements:

- Nominate a Player Safety Coach (PSC) who will complete the Level 1 Youth Tackle Coach Certification in 2016
- PSC will attend a four-hour, in-person USA Football PSC Clinic in 2016
- Maintain and provide proof of insurance that meets USA Football's requirements
 - \$1 Million General Liability
 - \$25,000 Accident and Health/Participant Accident
 - Add Heads Up Football, LLC as an additional insured
- Require all coaches activate a USA Football coach account and complete the Level 1 Youth Tackle Coach Certification (\$10/coach)
- Conduct a Heads Up Coaches Clinic for all head coaches led by PSC and a Heads Up Parents Safety Meeting led by PSC and/or head coaches
- Require parents/guardians sign release of liability waivers naming USA Football and Heads Up Football, LLC as released parties
